White suggested Ludington call Chris Richardson with Joe D. Hall to see if there would possibly be a warranty on this project & T. White stated the commissioners would provide a letter giving permission for CED #8 to check out the damage. T. White reported on the security updates within the Woodward County courthouse stating we have the plans prepared by Kline Mechanical but Williamson does not have a construction management certificate, we need to see if this is allowed by the State Auditor because we need an engineer to oversee the project, Mingus reported she needs to send the bid to three vendors & not sure what she is doing & needs some direction. White to advertise to schedule a public hearing & resolution to close a county road located from State Hwy 50 & EW county road 36 then East 1 mile to intersection EW36 & NS 215 in District #1 seconded by Thorn Roll Call Thorn-yes, C. White-yes & T. White-yes. Thorn, C. White, T. White, Lucas & Dunlap went on the annual tour of the Woodward County Juvenile Detention Center, there is 14 employees at this time they are housing 4 kids with the capacity of 10 kids, they have replaced resident room doors with OJA paying \$20,337.49 & Woodward County paying \$13,558.33 they are also needing a padded room just recently they had a 13 year old girl that was out of control & very abusive to the employees this padded room is much needed they have filed this with OJA asking them to pay \$29,419.35 & Woodward County paying \$5191.65, The detention center is very clean & very well run by Brooke Laird with Kevin Evans overseeing the facility. The detention center was built in 1982 & one of the best in the State of Oklahoma, we toured the living room, classroom, living
