Lucas reported water resource grant applications due by September 1st, there is a USDA inferstructure grant for distressed communities & rural energy program. Wilcox (election board secretary) suggested updates for physical security in preparation for the 2024 presidential election year, the State Election Board has given us some suggestions to protect our staff & equipment from threats. Some suggestions are: installing a barrier between employees & the public space. Installing panic alarms. It is suggested that we have panic alarms at each desk area & our vote center area where equipment is also secured. Upgrading locks & strike plates. It is recommended that we have one room within our office space that has a metal-clad door. This can serve as a safe place that employees could retreat to in the event of an intruder. We have a storage closet in our office where this would be ideal. C. White stated the architects are coming from Joe D. Hall & we will address these safety measures. Resolution R-18-50 that was approved in the BOCC meeting 9-24-2018 Permanent closure of a 2.3 mile section line road from the intersection of E540 Road & County Road 224 approximately 2.3 miles north to .1 south of east west 520 & 224 sections 3 & 4 T20N R17W & sections 33 & 34 T21N R17W in District #1, Thomas explained that one of his neighbors has cut an H Brace in order to get a swather in through his fence & said he would fix everything and has done nothing T White reported that is road has been closed since 2018 as per Carolyn Wycoff's request & surrounding land owners. Brandon Spray an adjacent land owner said all it would take is a simple phone call & we would do anything to help him. T. White & Mitchell stated this is a civil case. Motion was made by C.
